1. Opening Meeting

1.1 Devotions

James shared a devotion:

It was said of David that he served God's purpose in his generation (Ac 13:36) and it was said of the men from the tribe of Issachar that they 'understood the times and knew what Israel should do' (1 Chr 12:32). What is our generation? What is our time?

In Judges 2:10-11 it says, "After that whole generation had been gathered to their ancestors, another generation grew up who knew neither the LORD nor what he had done for Israel. Then the Israelites did evil in the eyes of the LORD and served the Baals." In the book of Judges we see a moral deterioration in Israel that resulted from them forgetting the LORD.

Western society is also forgetting its Christian roots and has been unchaining itself from God and his values. And we have probably not yet seen the full fruit of those decisions. Instead our societies continue to benefit, without realising it, from our Christian roots. While it is very easy to think that things have always been this way and will always be this way, we live in a very different society from our parent's generation or our grandparent's generation.

In the book of Judges we see similarities with our own generation; society unchained from the LORD and his values, tribalism, everyone doing as they see fit, a lack of contrast between society and God's people, loss of the holy or sanctified, reduced respect for authority, and even a personality culture.

Judges 21:25 'In those days Israel had no king; everyone did as they saw fit.' But as God's people we now have a King and we have a coming Kingdom.

In that context is Christian Schooling in our generation important? Growing a generation who both know the LORD and what he has done for his people.

3. Curriculum Reports (NAG 1)

3.1 Kahui Ako Annual Report

Kahui Ako Report dated 19 March 2021 circulated and taken as read. Vanessa Gatman and Ann Bailey (Across School Leaders) are in attendance to answer any questions.

In 2020 a series of PD took place which were implemented as a response to the exponential growth of domestic ELL's (English Language Learners) at KingsWay School. The PD was based around the seven ESOL principles. The team of Within School Leaders worked very hard to support staff in this area in addition to their collaborative inquiries which were also based on ELL. Overall, despite the lockdowns, our Kahui Ako was able to ensure staff had been given the tools to adapt their pedagogy to cater to the needs of these students and so improve student outcomes.

Data (graphs) were presented

This year we will be supporting staff in numerous ways to ensure that the principles are embedded in both planning and teaching.

Our aim for 2021 is to ensure that this focus encompasses not just the needs of the individual students but their whanau. We are looking at initiatives to include parents and caregivers by providing school communications (including meetings) in their first language.

Towards the middle of the year we will be introducing the Wellbeing focus. We intend to do this in tandem with the Wellbeing Framework which will be introduced to the school shortly. This is an MOE requirement, however the leaders have agreed not to rush to change focus, it's a ten year journey therefore pressure off.

Graeme - Commended Ann and Vanessa as leaders. Will need to find a replacement for Vanessa as Across School Leader.

The KWS ECCs are officially part of our Kahui Ako.

Confidence level vs results - gather student data this year for outcomes. Longitudinal studies year on year. Identifying students this year.

Board noted the high number of ESL students in the school is not represented in the make up of the board. The Chair invited Ann to make recommendations to the Board how we could attract representation from this sector.

4. Finance Report (NAG 4)

4.1 Finance

Monthly Financial Reports and Draft Financial Statements for 2020 circulated and taken as read

February results:

As a result of the impact of the roll increase and the MOE only recognising the financial implication of this at the end of March, we will review the 2021 budget and confirm a revised budget (if necessary) by June of 2021. All efforts will be made to remain within the original agreed deficit and there is at this stage little expectation that this number will be altered, it is the hope that this number will be decreased.

Special Character donations are down, reminders were sent and we have since received some payments. This is being closely monitored.

Draft Financial Statements:

We have ended close to where we thought we would end.

Revised Capex / Project Budget:

Gina shared the revised figures as a result of Phase 2 of Te Kainga being completed in 2021 the capex budget requirements have changed. Additionally, the school is to pay for the plants and gardening in the Te Kainga space which was not previously considered. The plan is for the Board to approve an amount of \$75k for planting, the financing comes from our results within budget.

We have decreased the amount to \$15 for schools.

Working capital still looks like we will make the \$500 per student. The FAPC are committed to achieving this figure.

10YPP Expenditure 2020:

The program is continually updated.

Digital Signboard Proposal circulated and taken as read

The ELT proposes to install a digital signboard at the Junior Campus. The ELT first proposed this motion in 2019; however, the Board wanted to generate more donations before committing to the project. The recent donation allows the board to push play on the project and communicate to the community that most of the funds were donated. Three providers were contacted, but Canon is a front runner in cost, quality, aesthetics, and support. Their representative mentioned that they are basically installing the sign at cost as part of developing an ongoing relationship with KingsWay. Canon provides the school's photocopiers.

Fourteen parents have indicated, in the Getting Stuck-In questionnaire (2020 & 2021), that they will advertise on the digital signboard.

Discussion:

- The donation had no strings attached. Happy to spend as we choose.
- Cushla explained how their school's signboard is a community hub, interactive and great exposure.
- Can be used for inspiration and special character.
- Can be made to pay for itself quicker, when it's freehold will be an income stream.
- Will be covered by our insurance (re vandalism) as it's a fixed asset, and inside school grounds.
- Advertisers have a contract with SC alignment.
